Use this form to request termination of a licence by the NSW Department of Planning & Environment – Crown Lands (the department).

## **Important information**

The department will assess your request for termination. Lodgement of this form does not guarantee that your licence will be terminated.

The department may require you to undertake certain activities, such as remediation of land, removal of structures or payment of outstanding amounts prior to termination being considered.

The termination of a licence does not waive any outstanding rent on the licence. Any amounts outstanding upon termination will continue to be a debt that is pursued by the department.
